A local law INCREASING THE MAXIMUM ALLOWABLE VETERANS EXEMPTION

SECTION 1: Section 458-a(ii) of the Real Property Tax Law authorizes a Town to increase the maximum allowable exemption granted to veterans for real property tax purposes.

SECTION 2: Said exemptions are set forth in Real Property Tax Law Section 458-a(2)(a), (b), and (c).

SECTION 3: The Town of Groveland, New York hereby increases the maximum allowable exemptions granted in said provisions to fifteen thousand dollars (a), ten thousand dollars (b), and fifty thousand dollars (c) respectively.

SECTION 4: Said increase shall be effective with the 1998 assessment roll.

SECTION 5: This Local Law shall be effective upon the filing with the Secretary of State, State of New York.
