Local Law #1-2011 Modifying the Compensation of Judge Love Of the Town of Groveland, Livingston County, New York

Article 1: Introduction

Section 1. Authority

Be it enacted by the Town Board of the Town of Groveland as follows:

The Town of Groveland increases the annual salary of any such elected officer may be increased, for not more than one fiscal year in Section 27 of the Town Law and Article 2 of the General Municipal Law.

Section 2. Title

This local law shall be known as the "Modifying the Compensation of Judge Love"

Section 3. Purpose

By adoption of this law the Town of Groveland declares a vacancy has occurred with the resignation of Justice van Munster effective August 12, 2011, which would leave the town with one justice until the November 2011 election allows for a replacement. And that such sitting justice known as Justice Love whose term expires December 31, 2011 will assume the duties of two justices until replacement is effective January 1, 2012. It is the intention of the town board to utilize the remainder of Justice van Munster's 2011 salary and add it to Justice Love's 2011 salary to ensure that the business of the Town Justice court is administered efficiently and that matters are adjudicated in a timely manner to protect the rights of individuals appearing before the court.

Section 4. Effective Date

This local law shall take effect immediately upon the filing of the local law with the Secretary of State.
