Section I. Local Law No. 1 of the year 1986 of the Town of Groveland is hereby repealed and replaced by this Local Law.

Section II. The day for hearing complaints in relation to assessments (commonly known as Grievance Day), shall be changed from the fourth Tuesday of the month of May to the Thursday following the fourth Tuesday of May.

Section III. This Local Law shall take effect immediately upon filing in the office of the Secretary of State.

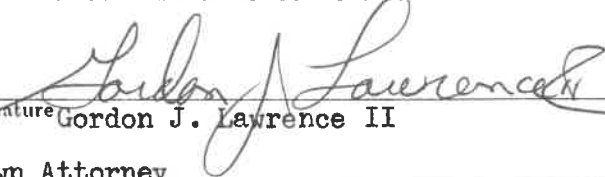
