Section 1.

This Local Law is adopted pursuant to the authority granted by Real Property Tax Law §459-c. All definitions, terms and conditions of such statute shall apply to this Local Law.

Section 2.

Real property owned by a person with disabilities whose income is limited by such disabilities, and used as the legal residence of such person, shall be entitled to a partial exemption from taxation up to 50% of the assessed valuation.

Section 3.

To be eligible for the full 50% exemption authorized by Real Property Tax Law §459-c and implemented by this Local Law, the maximum income of such person shall not exceed \$12,500.00. Any such person having a higher income shall be eligible for an exemption in accordance with the following schedule:

ANNUAL INCOME	PERCENTAGE ASSESSED VALUATION EXEMPT FROM TAXATION
<i>More than \$12,500 but less than \$13,500</i>	<i>45 per centum</i>
<i>\$13,500 or more but less than \$14,500</i>	<i>40 per centum</i>
<i>\$14,500 or more but less than \$15,500</i>	<i>35 per centum</i>
<i>\$15,500 or more but less than \$16,400</i>	<i>30 per centum</i>
<i>\$16,400 or more but less than \$17,300</i>	<i>25 per centum</i>
<i>\$17,300 or more but less than \$18,200</i>	<i>20 per centum</i>
<i>\$18,200 or more but less than \$19,100</i>	<i>15 per centum</i>
<i>\$19,100 or more but less than \$20,000</i>	<i>10 per centum</i>
<i>\$20,000 or more but less than \$20,900</i>	<i>5 per centum</i>
