Section 1.

Section 3 of Local Law No. Two of the year 1998 entitled "A Local Law Providing a Partial Exemption from Real Property Taxes to Persons With Disabilities Limiting Their Income" is amended to read as follows:

Section 3.

To be eligible for the full 50% exemption authorized by Real Property Tax Law S459-c and implemented by this Local Law, the maximum income of such person shall not exceed \$13,000.00. Any such person having a higher income shall be eligible for an exemption in accordance with the following schedule:

<u>ANNUAL INCOME</u>	<u>PERCENTAGE ASSESSED</u> <u>VALUATION EXEMPT FROM TAXATION</u>
More than \$13,000.00 but less than \$14,000.00	45 per centum
\$14,000.00 or more but less than \$15,000.00	40 per centum
\$15,000.00 or more but less than \$16,000.00	35 per centum
\$16,000.00 or more but less than \$16,900.00	30 per centum
\$16,900.00 or more but less than \$17,800.00	25 per centum
\$17,800.00 or more but less than \$18,700.00	20 per centum
\$18,700.00 or more but less than \$19,600.00	15 per centum
\$19,600.00 or more but less than \$20,500.00	10 per centum
\$20,500.00 or more but less than \$21,400.00	5 per centum




