Increases the maximum allowable exemption granted under paragraphs (a)(b)(c) of subdivision (2) of Section 458-a of the Real Property Tax Law from \$15,000 (15% wartime veteran), \$10,000 (additional 10% combat veteran) and \$50,000 (50% for disabled veteran) to \$21,000, \$14,000 and \$70,000 respectively. Said increase shall be effective with the 2007 assesment roll and there on.
